

- Good news current growth rate has declined to about 1%





Annual rate of population change from 1950, including UN projections to 2099 based on its median scenario. This takes births, deaths and migration into account.



Projected population to 2100 is based on the UN's medium population scenario.






Why Does This Matter?


Environmental Effects of Overpopulation

Shouldn't We Get Our Own House in Order?

Rather than pointing fingers at other countries, many of whom suffer very high poverty rates and have much lower per capita emissions rates

ABSOLUTELY!

- We need to get our own house in order.
- However, it is not an either/or proposition.
- Working to decrease our own emissions does not preclude working to decrease population growth.

Nor is it a question of pointing fingers or coercion

Millions of women (and men) in Lower and Middle Income countries currently want access to modern contraception, and do not have it.

Expanded services are needed to fulfill unmet needs in LMICs

923 million women of reproductive age want to avoid a pregnancy 218 million of them have an unmet need for modern contraception


Many data also show that providing education to girls results in lower fertility rates.

Providing access to reproductive health care, including access to contraception and providing access to education, are important environmental issues.

And they are also women's rights (affecting primarily women of color), and therefore human rights issues.

Is Fighting Overpopulation Racist?

When discussing overpopulation, I am often told that trying to do something about it is racist, because it is primarily Asia, Africa and South America that are suffering from overpopulation. I am also told that it is racist to try to restrict immigration into the United States.

ABSOLUTELY NOT!

- What I want to see the West do is help people have a better life, by helping them get access to both modern birth control, and education
- I also think that it is misguided to conflate immigration and overpopulation.

What Can a Middle Class American Do?

• Support efforts by organizations like Population Connection and Planned Parenthood to provide reproductive health services, including modern contraception, to all women who want them. This includes lobbying to increase Federal funding for women's health globally.

• These and other organizations are also working to permanently end the "Global Gag Rule". This has been implemented by every Republican president since Ronald Reagan. It prevents foreign organizations receiving U.S. funding from providing information, referrals, or services for legal abortion, even with their own money.

• The Gag Rule not only hinders efforts to provide women with health care and reproductive services, it also, ironically, results in an increased number of abortions worldwide.

• Support efforts by organizations like The Malala Fund to increase funding for female education worldwide.
